

Judge Anderson discussed briefly about the sick and vacation hours for the EMS, Jail and Dispatch. He explained to court members how these departments are unique from the others. EMS being the most unique because of the 24 hour shifts. Even though all departments fall under the counties policy there has to be a better way to address these departments concerning their sick and vacation time. EMS employees have been working on a proposal to bring before the court addressing their sick and vacation time. Judge Anderson told members that he would get them a copy of the proposal and ask if they could meet to discuss this and see what can be done budgetary wise. Judge Anderson said we need to address this to see if there is a fair way to make each department a policy that will work for them.

Treasurer made court members aware that the application had been submitted to purchase the 2019 Mack truck.

Judge Anderson made court members aware that he would be getting some quotes from Detroit and Morton Salt for road salt to use for the upcoming winter.

Judge Anderson also made court members aware that one of the older salt truck was sold during our county auction so to fully utilize the salt equipment they would need to look into painting another one prior to winter.

Magistrate Tipton said he thought it was an important to have a list of roads to the people so when there is a snow event everyone knows where they will be going. He suggested doing a dry run to go over the roads while using their radios.

Judge Anderson also told Road Supervisor Daniel Clair to call and check and see if they are going to reactivate the GPS's on the salt trucks for the winter months.



Departments Heads:

Assistant Ambulance Director Arlene Rogers made the court aware that 2 trucks were down. Judge Anderson made court members aware that Ambulance Director Nathan Hall was contacting Teresa Shield with R&D to see where the grant process stands about getting 2 new trucks.

Road Foreman Daniel Clair told court that each truck had its own list of roads for the snow routes.

Judge Anderson told court that there had been a lot of drainage issues and the road department is doing their best to address these issues.

Solid Waste Coordinator Tim Snowden made the court aware that the free tire amnesty days for the county will be held at the State Garage Thursday, Friday and Saturday until noon (October 11th, 12th and 13th). We urge everyone to get the word out to take advantage of these days.

Then new compactor should be here in December. Judge Anderson said we are excited to get the new compactor and get everything back in order. He said he thinks the court made the best decision for the county in purchasing the new compactor.
