A Zoom meeting using audio/video was held in the Office of the County Judge Executive Room 102 practicing social distancing.

Judge Executive James Anderson was the administrator/host of this meeting. Those present for the meeting were Judge Executive James Anderson, Fiscal Court Clerk Connie Crabtree and County Attorney Robert King.

Judge Executive James Anderson called the meeting to order at 5:00 p.m. Judge Executive James Anderson ask the Fiscal Court Clerk to call to roll:

#### **Emergency Project Discussion:**

First item on the agenda was the discussion of the Emergency Projects. The bids for these projects were opened and there were some discussion of them during the Fiscal Court meeting held on June 9<sup>th</sup>, 2020. Judge Executive James Anderson said that he had looked over them and noticed that King Crete Drilling didn't include paving on their bid but Hinkle Environmental Services had.

Mr. Anderson said he feels that the best thing to do before our special meeting scheduled to be held on June 29<sup>th</sup>, 2020 would be to contact Mr. Ruben Tuner with Hinkle Environmental Services and ask him to quote what the cost would be to do that amount of paving and then we could more fairly compare who's high and low. He said if all is equal we need to see which one can get to the projects the quickest. Members of the court all agreed with Judge Executive James Anderson to contact Mr. Ruben Turner with Environmental Services, LLC. to get a quote for the asphalt.

No Action Taken

Employees Pay Raises: 7/1/20 - 6/30/21

Judge Executive James Anderson made members of the court aware that he had figured what a 2% verses .25 cent would be. Each member of the court that was present looked over the printouts that Judge Anderson had prepared. He said he thought it may be safer to go with the .25 cent increase for the time being. Regardless we need to decide if this just would just include our full time employees or do we also need to include our part-time employees.

Magistrate Mike Lockard and Magistrate Chad Patton said they feel that part-time employees should also get the .25 cent increase. Magistrate Dennis Combs said he feels it should be across the board. This increase would be for all county departments employed under the Powell County Fiscal Court and not under another elected office. This would also exclude the jail employees.

Magistrate Chad Patton said he thought most of our part-time employees has been here for over a year. Judge Executive James Anderson said he would like to consider our permeant part-time employees.

Judge Executive James Anderson also said that if someone is getting a raise because of a position change or some of the lesser positions such as Mapping Officer, Tax Enforcement and Fire Aide would not receive a raise.

Magistrate Chad Patton said he feels if an employee has been here for one (1) year they should also get the .25 cent increase.

Members of the court discussed that regardless of a full or part time status if an employee has been employed under the Powell County Fiscal Court and not under another elected office that has been here for one (1) year or more would be eligible for the .25 cent increase.

A motion was made by Magistrate Chad Patton seconded by Magistrate Dennis Combs to approve all employees that is directly employed under the Powell County Fiscal Court and not under another elected office that has been here for one (1) year or more shall receive the .25 cent increase starting the new Fiscal Year 7/1/20 - 6/30/21. This would be a total \$520.00 for each employee. If an employee has two or more positions they will only receive one \$520.00. If an employee is getting a raise due to a position change they will not receive the .25 cent increase. The .25 cent increase will become effective for the new Fiscal year beginning 7/1/20 through 6/30/21.
