Judge Anderson called the meeting to order at 6:00 p.m.

Judge Anderson ask for a moment of silence in remberance of Former County Judge Executive Bobby Drake, Former County Clerk Scotty Frazier and County Surveyor Kevin Davis.

Public Comments:

Residents from Woody Ware Road:

Eric Briscoe approached members of the court to ask them their thoughts on the flooding problem on Woody Ware Road. Eric told them that they have to deal with a lot of flooding there. Right below Doug Everman's there is a low curve and their main concern is when it gets over there they cannot get out until the water goes down. It sometimes can go down quick but then other times it can take several days to finally go down. There are several concerns like health issues, someone's house catching fire as well as people needing to get to work. They have recently seen the work that has been done on Pompeii Lane and everything looks great but he is a little concerned after this last flood the water is being displaced to this curve quicker than normal. Eric said he had talked to Judge Anderson and Magistrate Dennis Combs about this. They all have learned how quickly water comes up and know what goes first, it's the lane, Red River Ranch and then to Shepherd's Printing. Once it does go over at Shepherd's Printing then it's over the curve and if it does get worse its then at Jackie Rose's straight stretch. The worst he has seen it is right when you turn into Katie Drive there is a bridge and he has seen it get this far. It's like clockwork but this last time it did not work like that way. He said his wife called him around 8:30 and said it was already in the curve. He went out around 9:00 it was over the curve and almost coming over at Jackie Rose's and over at the other places too. Eric said he worries that



if they get a worse flood it will come a lot quicker. Eric also said he wonders if those box culverts that was supposed to be put in the beginning really should have been put in. He knows it would not fix the problem but may have brought them some time. He ask members of the court what they thought could possibly be done to get them out if it does flood.

Another gentleman approached the court and told them that they had been discussing possibility another way out such as a right of way of someone's farm land or property. It may could be where the old road cuts through the Sayler's farm or maybe the end of Shiloh Road.

Judge Anderson told the property owners that his first term some of these flood ligation issues is what they took to the state. This is how long it has taken from getting it put into the six year plan till actually starting it due to the lack of funding with the Transportation Cabinet. There is confusion as to what the project was. When Pompeii Lane, Rosslyn and Bowen was identified the engineers was asked if anything could be done with the minimum flooding such as keeping school buses, people going to work and emergency services to be able to access them. They shot for an elevation that would maximize what they could do without actually backing it up and damming it. The question would be is it doing what it was designed to do which was gauging the low curve on Woody Ware Road. In theory it would stay out as long as the lane was is out. Originally the lane across there where water broke over was 15 ½ foot was where water started reaching the lane. This project was designed to bring it up to 17.25 feet so in theory when it completed 17.25 you should not be driving across water. Not the most recent flood but the one before was 20.33. If this project had been to where it was supposed to be the 20.33 it would not have fixed the problem for a portion of it but they would have gained 13 ½ hours. It looks like it is about a foot off on a portion of it as far as the elevation.

The Judge told them in referring to the box culverts the point is that it's basically kind of a dam until it breaches all the same elevation. In looking at the pictures of the curve on Woody Ware Road it looks like the project was accomplished. It was supposed in theory keep you out of water until 17.25. Beyond this project we have also anticipated the canal project. If we get the hydrology study even something as small as this project becomes more helpful. In relation to the flood in Clay City the State just awarded the Adams Ridge Project which is a lot in population.

Back to the discussion of Woody Ware Road there are 3 potential property owners that may have an interest in working with others in making an exit out. We would also have to determine how much the cost would be to do this. All members of the court are open in looking into this.

When you go past Woody Ware and turn up Shiloh Road and it dead ends in a cul-de-sac. Right to the middle of the cul-de-sac through a property owners yard you could come out into John Salyer's property and follow a tree line which would come out across from Beech Fork where Drew and Chad Birch lives which seems to be the most logical place for an road to come through for an exit. Judge Anderson said that the court is open to this but would it be better to initiate this from a group of landowners and then the court could look into what the cost would be.

Judge Anderson said he thought would if we could obtain an easement or a flood access lane that would be only open to them. Magistrate Tipton suggested that cattle guards and a fence to make it a temporary easement. County Attorney Robert King said that he did not care to contact the landowners to see if this could be a possibility.

CSEPP/EMA Director Kevin Babcock update:

Judge Anderson let members of the court aware that CSEPP/EMA Director Kevin Babcock could not attend the meeting due to personal issues but wanted the court to know that all sirens were working but 4 and 3 of them are battery related. Hopefully this August Madison County will be giving us batteries.

We also need to do a county wide CODE RED test and encourage citizens to participate in the CODE RED alerts. The county spends around \$12,000.00 for this and is a great tool that we provide to our citizens.

New Business:

Magistrate/District Updates:

Magistrate Chad Patton – He had a caller to complain that the snow was not pushed up far enough. Magistrate Timmy Tipton – Told members that he along with Judge Anderson and Road Foreman Patrick McCoy had a conversation about the snow event. Patrick told them that they had some issues with clogging. The new salt boxes works really good with pure salt and not with blending. These boxes are so efficient and does not waste. They had to spend a lot of time unclogging the boxes.

Another issue was that a fire truck got blocked in on North Bend Road.

Ambulance Director Nathan Hall told members of the court that traffic control is the fire departments problem. Judge Anderson said there needs to be a protocol looked at on road conditions before going out. There was so many wrecks with this snow event which caused a lot of road to be blocked. Magistrate Tipton said this snow event allowed the road crew to see what was possible and they learned some things. It was disappointing that the salt boxes clogged and they spent a lot of time unclogging them. Judge Anderson said that he did not think it was so much of the mixing ratio it was part of having the over summer salt caused the clumping of it.

Magistrate Dennis Combs – One complaint on Virden Springs Rd. He said he spend a few hours with the road crew Friday night during the snow event and they do such a good job.

Magistrate Mike Lockard – Mention the new faucets installed in the courthouse and also new carpet is going down in the courtroom.

Magistrate Donna Gabbard – Guardrail on North side of Furnace Mtn. which is a relief because of it being so dangerous. She had no calls during the snow event.

Judge Anderson said that our road crew did a wonderful job. The effort was there and he's not saying it was the best respond but this snow event came so quick.

He said our public does not know the difference between public streets, state roads or county roads which is unfair to all departments. The state was out on roads and was doing the best they could do with what they had. Until something is done about the gas user tax offices are strapped for funds. During the snow event 60 to 70 percent of the traffic that was out on the roads was unnecessary traffic. The public needs to be aware if their road did not get the attention they thought it should have does not mean we don't care. There was a call that came in at the road department. The person was cussing out the road crew. Judge Anderson called him back and explained to him that the road is was calling about was a state road. We do know the public is appreciative of the work and for the small road crew we have they do an excellent job.

Zoning Letter from B. Scott Graham: RE: City of Clay City-Zoning:

Judge Anderson made members of the court aware that he had received a letter from B. Scott Graham. The letter stated that the City of Clay City and the City Council of Clay City have expressed an interest in adopting zoning regulations for the City of Clay City. Per KRS 100.117 the City is required to interrogate the county and every other city therein to determine whether they desire to enter into an agreement to form a joint planning unit. If there is interest in joining the City of Clay City in forming a joint planning unit, please contact the City Clerk or Mayor Carmichael regarding same within the next 60 days. If the City of Clay City is not notified in writing within 60 days that either the City Of Stanton or the Powell County Fiscal Court is interested in forming a joint planning unit, then the City of Clay City will assume wither is interested in same and will engage in an independent planning operation. Judge Anderson said that they tried to initiate this a couple of years ago and has now expired so they will have to do back through the process. Judge Anderson ask what the pleasure of the court concerning this letter. Magistrate Mike Lockard and Magistrate Dennis Combs said they are for zoning. Judge Anderson said that the public is starting to recognize the importance of it. With our growth here in the county we need to make sure our infrastructure is protected and our citizens. Magistrate Chad Patton said he would like to see us work together and this would be a step closer to charter government. Magistrate Tipton also agreed to it just as long as there is a model to fits us. We could contact Bluegrass Area Development to help us with a suitable model. Judge Anderson said going down the road to explore this does not hold us to anything.
