Emergency Projects – Brush Creek, Spaas Creek and Star Gap Road:

Brush Creek and Spaas Creek were previously awarded state funding for these Emergency Projects. The Brush Creek Project was awarded \$26,684.00 to address around 100 feet of stream bank that is cutting into the road. 


