STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Powell County is current as of November 1, 2018. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86765 on May 19, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

KY 11, from the Wolfe County Line via Natural Bridge State Park to the intersection with KY 15 at Slade, a distance of 3.598 miles. (MP 0.000 to MP 3.598)

KY 9000, from the Clark County Line via the Bert T. Combs Mountain Parkway to the Wolfe County Line, a distance of 24.087 miles. (MP 11.913 to MP 36.000)

STATE SECONDARY SYSTEM

KY 11, from the intersection with KY 15 at Slade, via Nada, Rosslyn, Stanton, and Clay City to the Montgomery County Line, a distance of 21.441 miles. (MP 3.598 to MP 25.039)

KY 15, from the Wolfe County Line to a junction with KY 11 at Slade. Also, from a junction with KY 11 at Clay City via West Bend to the Clark County Line, a distance of 8.871 miles. (MP 0.000 to MP 3.493)(MP 3.493 to MP 8.871)

KY 77, from the junction with KY 11 at Nada to the Menifee County Line, a distance of 4.309 miles. (MP 0.000 to MP 4.309)

KY 82, from the Estill County Line to the junction with KY 15 in Powell Valley, a distance of 2.058 miles. (MP 0.000 to MP 2.058)

KY 213, from the Estill County Line, via Knowlton and Stanton to the Montgomery County Line, a distance of 12.076 miles. (MP 0.000 to MP 12.076)

KY 1057, from the junction with KY 11 in Clay City, via Eleventh Street in Clay City to the junction with KY 213 near the Estill County Line, a distance of 9.566. (MP 0.000 to 9.566)

RURAL SECONDARY SYSTEM

KY 599, from the junction with KY 613, north of Bowen, to the Montgomery County Line, a distance of 5.764 miles. (MP 0.000 to MP 5.764)

KY 613, from the junction with KY 11 in Bowen extending northeast to the Menifee County Line, a distance of 9.680 miles. (MP 0.000 to MP 9.680)

KY 615, from the junction with KY 213 southward to another junction with KY 213. Also, from a junction with KY 213 north of Stanton to a junction with KY 599, a distance of 9.729 miles. (MP 0.000 to MP 4.122)(MP 4.122 to MP 9.729)

KY 1028, from the Clark County Line to the junction with KY 82 near Powell Valley, a distance of 4.711 miles. (MP 0.000 to MP 4.711)

KY 1050, from the junction with KY 599 near the Montgomery County Line to a point on the Montgomery County Line, a distance of 0.325 mile. (MP 0.000 to MP 0.325)

KY 1057, from the Estill County Line at a point east of Furnace to the junction with KY 1639, a distance of 6.700 miles. (MP 9.566 to MP 16.266)

KY 1184, from the junction with KY 11 in Rosslyn to the junction with KY 615, a distance of 0.477 mile. (MP 0.000 to MP 0.477)

KY 1639, from a point northeast of the Estill County Line to the junction with KY 11, southeast of Bowen, a distance of 6.542 miles. (MP 0.000 to MP 6.542)

KY 2001, from the Estill County Line to the junction with KY 1057,north of Vaughns Mill, a distance of 3.123 miles. (MP 0.000 to MP 3.123)

KY 2026, from the junction with KY 11 in Clay City, via Pompeii Road in Clay City, extending east via Maple Street in Stanton to the junction with KY 213 (Main Street) in Stanton, a distance of 4.202 miles. (MP 0.000 to MP 4.202)

KY 2073, from the junction with KY 11 in Stanton via Halls Lane to the junction with KY 2026 (Maple Street), a distance of 0.619 mile. (MP 0.000 to MP 0.619)

KY 3352, from the junction with KY 1028 to the junction with KY 15 near Virden, a distance of 3.974 miles. (MP 0.000 to MP 3.974)

KY 3354, from the junction with KY 1057 to the junction with KY 11 south of Rosslyn, a distance of 5.379 miles. (MP 0.000 to MP 5.379)

SUPPLEMENTAL ROADS

KY 1695, from the junction with KY 615 to the end of state maintenance, a distance of 1.754 miles. (MP 0.000 to MP 1.754)

KY 2476, from the junction with KY 2487 (Breckinridge Street) in Stanton, via Court Street, to the junction with KY 213 (Main Street), a distance of 0.204 mile. (MP 0.000 to MP 0.204)

KY 2479, from the junction with KY 11 (Sixth Avenue) in Clay City, via Third Street, Fourth Avenue, Second Street, First Avenue, First Street, and Fifth Avenue, to a junction with itself at Third Street, a distance of 1.146 miles. (MP 0.000 to MP 1.146)

KY 2480, from the junction with KY 11 in Clay City via Tenth Avenue to the junction with KY 1057 (Eleventh Street), a distance of 0.351 mile. (MP 0.000 to MP 0.351)

KY 2481, from the junction with Seventh Avenue in Clay City via Ninth Street to the junction with KY 11, a distance of 0.053 mile. (MP 0.000 to MP 0.053)

KY 2483, from the junction with KY 213 (Main Street) in Stanton, via South Sipple Street to the junction with KY 11, a distance of 0.223 mile. (MP 0.000 to MP 0.223)

KY 2486, from the junction with KY 11 in Stanton, via Washington Street, to the junction with KY 2476 (Court Street), a distance of 0.539 mile. (MP 0.000 to MP 0.539)

KY 2487, from the junction with KY 213 (Main Street) in Stanton, via Boone Street and Breckinridge Street to the junction with KY 2026 (Maple Street), a distance of 0.496 mile. (MP 0.000 to MP 0.496)

KY 3097, from the junction with KY 2487 (Breckinridge Street) in Stanton, via Atkinson Street to the junction with KY 2486 (Washington Street), a distance of 0.042 mile. (MP 0.000 to MP 0.042)

KY 3528, from the junction with KY 213 in Stanton via East Pendleton Street, to the entrance to the Kentucky Transportation Cabinet maintenance garage, a distance of 0.970 mile. (MP 0.0000 to MP 0.970)
